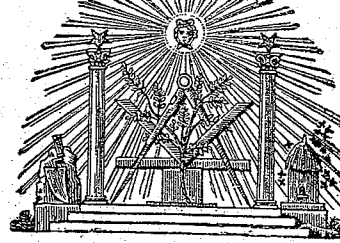

The W. B. Grand Orator being absent, the W. B. Feraud, Grand Treasurer, delivered the following speech, at the request of the M. W. Grand Master.

I will not detain you a moment, my Brethren, in expatiating on the difficulty of the task with which I am charged nor on the insufficiency of my means for its suitable accomplishment; our M. W. Grand Master, has called upon me to fill the place of our absent Grand Orator, and in obeying that call, I trust to your indulgence. Masonry, from time immemorial, has been defined by our most enlightened brethren, the study of the sciences and the practice of virtue. After this definition of which each of you are prepared to acknowledge the exactitude, is it not permitted to us to boast of the utility and excellence of the R. Art.

Its object is to render man happy; and what surer means are there of obtaining it, than those which it employs: to enlighten the mind by instruction, and to form the heart by example; is not this the object of our labors, of our work: Is it not the meaning of the mystery which has been discovered to you, in every degree to which you have been advanced. The wisdom of the G. A. gave and executed the plan of this sublime institution; strength supports and preserves it and beauty adorns and embellishes it; it is in vain that envy and wickedness would endeavor to subvert the edifice raised on these three pillars, in vain will calumny direct its poisoned arrows against it; its origin is lost in the obscurity of time, and its end will be closed but with that of ages.

What do these enemies object to our order? if you assemble but to do good, say some of them, why make use of the mystery which envelops your meetings; do you believe, say others, that you are the only well informed, the only virtuous order of men; to wind up, again; others pretend that if the mystery can have been useful in times now past, it is at the present day perfectly useless and often injurious.

Let us not, my brethren, be embarrassed or dejected by these idle clamours.

They reproach us with the mystery and the secrets which veil our meetings from the gaze of the profane; But, can the truth, that light which the mason desires and seeks after, be without danger exposed to all? If I held shut up in my hand all the truths, said the learned Fontenelle, I would take good care not to open it. Wise and philosophic thought! All those who have studied and obtained a knowledge of man, have been obliged to concur in opinion that all truths are not useful and that several might easily become dangerous if unveiled to weak minds. It is then reserved but to some, to be in a condition, without risk, to obtain a knowledge of all truths; well then the mystery by its wisely directed experiments serves to ascertain what quantity of light may be imparted to each without dazzling him with it. Such has always been the cause of the discretion, of which the mason contracts the obligation from his entrance into the T. We read in a manuscript discovered by the famous Locke, the original of which appears to have been written by Henry the 6th, who reigned in England en 1436 "that masons have at all times, and from time to time communicated to mankind such of their secrets as might be useful to them and keeping back only those which might be prejudicial in bad hands, those which be or could be of no benefit to others and those which serve to bind the fraternity more firmly together." But these very secrets do not, exclusively belong to any particular family, or particular people; the order is as universal as the cause which gave rise to it. The only recommendations necessary for admission to our labours are moral qualifications; distinctions and advancement belong but to merit; it is here that true equality reigns, the emblem of which decorates the collar of the senior warden; not that brutal equality that breaks all the bonds of society by refusing to acknowledge any authority; but that wise and charitable equality which cause us to consider all men as brothers of the same origin, participating of the same nature and destined to the same end.

We find, again, in the manuscript already quoted, the answer to other objections of our enemies? we therein find this question "are masons better informed than other men?" and then follows the answer: "they have only the right and the opportunities of knowing more than other men, but many want capacity and a still greater number the vigilance and aptitude necessary to the acquirement of knowledge; and to this other question: "Are masons better than other men?" The answer is: "That some masons are not so virtuous as other men, but they are better than they would be if they were not masons."

Is it not useless to answer those who wish to cause the mystery to be considered as dangerous; such a calumny is too absurd to require serious attention; and indeed, that a jealous despot who considers men but as victims devoted to his passions, sees not without uneasiness an association, whose chief end is to render all men happy; that the obligations and the oaths which masons take to be faithful to the government of their country, are not sufficient to remove the fears of the tyrant and that in his mischievous delirium he proscribes and persecutes them, we may easily conceive.

The perverse man cannot ascertain or appreciate the sacrifices which virtue knows how to impose, and besides the sight of a virtuous man acts as a reproach to him, which ruffles and puts him in a state of fury.

But, that this objection has been made in a republic, and in what Republic! In that, of which the fundamental basis seems to have had its source in the Masonic Code. In that of which the firm and liberal government leaves to man the exercise of all his liberty without converting it into licentiousness and gives to authority all the force and power due to a law, without its being able to convert it to despotism. What! could our republic have any thing to fear from those who at their meetings, after having paid that homage to the G. . . A. . of the U. . which is due to him and sought a benediction upon them and their works, have no other care, no other occupation than that of seeking after the means of assuring the happiness of their fellow men! No, no, let not yourselves be deceived, it is not for the safety of the republic that these enemies of the mystery tremble; for rather are these enemies of the mystery the enemies of the republic. They well know that so long as freemen assemble in their T. . . that they support wisdom, strength and beauty, where power is given to those who bear on their breasts the emblem of the virtues which are in their hearts, equity, equality and rectitude, so long as they shall be conducted by the three great lights which impart to us our intelligence: morality, equity and moderation, in a word, so long as there shall exist Masons, the American Republic will have devoted and constant supporters.

As to the inutility, which is offered as a reproach to our institution, the ignorant man or the man of bad faith can alone attempt to suggest it. Experience proves to us that by a whimsical destiny of the human mind, the best things degenerate by making them too general; would not that cause suffice for rendering obvious the necessity of an association more especially consecrated for the preservation of the deposit of human knowledge and for giving an example of the virtues; and our society being at the same time a private society where none are admitted but those whose virtues render them worthy and a general association where none but the wicked are excluded, ought it not to be considered as an institution the most fit to fulfill that useful mission. Give to a certain class of men this sacred deposit, would it not be lost when that class might be dispersed; it was confided to the Bramins and disappeared with them; the Priests of Memphis assumed the keeping of it, but it was buried under the ruins of the Egyptian priesthood; its lot was the same at Eleusis. A like inconvenience exists when it is intrusted to one nation; most powerful people have by turns been effaced from the surface of the earth and their sciences have disappeared with them; but the religious system might succeed and decay; nations might rise and fall without the masonic edifice, being affected; it has gone through past ages and will go through ages yet to come, always shedding on them lights and benefits.

It is however true that all our Lodges have not always worked with the same purity of principles; we have unfortunately seen the most culpable passions slip into them; intrigue has sometimes carried off that which merit alone ought to have obtained, personal interest has been allowed to succeed, when nothing but universal

charity should have been listened to; the funds of the lodges have been diverted from their destination and they have not always been very scrupulous as to the means of augmenting them; but it is the abuse of the thing and not the thing itself.

Will they say that liberty must be renounced because they have caused it to degenerate into licentiousness? must we cease to preach equality because the principle might be made use of to break in pieces the salutary yoke of the laws. Ought one to despise logic because there have been sophists? and ought the morality of divers religious systems to be held less precious because their ministers have misinterpreted the meaning of it to satisfy their private interest? No, my brethren, the abuse of a cause ought not to occasion its rejection. If corrupt men are unfortunately introduced into our order, far from yielding to them our Lodges by a cowardly abandoning, let us run there with zeal; armed with whips let us drive away from its sacred bosom those speculators and profaners who pollute its sanctity by making it a place of traffic and debauchery. Bring back by your fervency and your perseverance those happy times when all masons formed, really and from the heart but one family of brethren, united by ties of ardent and active charity, that the symbols that here strike our sight may not be a vain parade, a spectacle, which I will dare to say would become ridiculous if they spoke not to our souls.—Let us distinguish ourselves rather by our virtues than by our decorations: that our actions may prove the purity of our morals, in a word let us be true and faithful masons, it is the best means of reducing our detractors to silence, of obtaining the approbation of the wise, and of meriting to be one day admitted into that heavenly and everlasting lodge wherein presides the G. . . A. . of the U. .

—The Spontaneous and reiterated bursts of applause which succeeded the Oration, testified to the W. B. who had delivered it, the high satisfaction which had been inspired by a discourse so well calculated to strengthen their affection for the Order, and excite in their minds a firm resolution to remain steadfast in the practice of its principles.

RESOLVED, that no Brother who has been elected to any office in the Grand Lodge, shall have the right to decline the accepting said nomination, unless she hall have filled the same place during the preceding year.

RESOLVED, that when at elections of the first four officers of the Grand Lodge, no Brother shall obtain a majority of all the votes, on the first ballot, the second ballot shall be between the two highest, and if it should to happen that the result of said ballot should produce the same number of votes for more than two Brothers, then the subsequent ballots shall be between the two who are senior members of the Grand Lodge.
